"My Enemy—My Friend" Brigadier General (Ret.) Dan Cherry, USAF

Dan Cherry entered the Air Force in 1959 as an Aviation Cadet, and was commissioned a Second Lieutenant in 1960. His military credentials include flying 295 combat missions during the Vietnam War and shooting down a North Vietnamese MiG-21. During his Air Force career, he held the positions of Commander and Leader of the Air Force Thunderbirds; Commander of Moody Air Force Base, Georgia; Inspector General of the Pacific Air Forces; Commander of the 8th Tactical Fighter Wing flying the F-16 and Commander of the Air Force Recruiting Service. He earned several military awards and decorations including the Distinguished Service Medal, the Silver Star with one oak leaf cluster, the Legion of Merit with two oak leaf clusters, the Distinguished Flying Cross with nine oak leaf clusters and the Air Medal with thirty four oak leaf clusters. He completed his service in the Air Force with the rank of Brigadier General.

He is a graduate of the Florida Southern College, the University of Southern California, and the National War College and Industrial College of the Armed Forces. Dan also served in Kentucky state government as Secretary of the Kentucky Justice Cabinet. He is a member of the Kentucky Aviation Hall of Fame, the Georgia Aviation Hall of Fame, the Georgia Aviation Hall of Fame and the Western Kentucky University Hall of Distinguished Alumni. He is also Director Emeritus of Aviation Heritage Park, an educational facility in Bowling Green, Kentucky.

He is married to the former Sylvia Cooper of Smyrna, GA. They have two daughters and four granddaughters.

Brigadier General (Ret.) Cherry is the author of, *My Enemy...My Friend, a story of reconciliation from the Vietnam War.* This inspiring book chronicles an intense 1972 dogfight between Dan's F-4 Phantom and a North Vietnamese MiG-21 and his subsequent meeting and friendship with the MiG pilot, Nguyen Hong My. Sequestration still limits flexibility by the services to manage their personnel, TRICARE Standard changes will become effective 1 January 2018, and the VA Secretary is planning to overhaul the "Veterans Choice Program". I recommend you keep informed—and take action when you feel so moved—by visiting www.moaa.org and scrolling down to the daily updates to the legislative section.

Our chapter's pre-Memorial Day remembrance ceremony was held on Saturday, 27 May at 10:00 am at the Middle Tennessee State Veterans Cemetery on McCrory Lane with a small group attending. Legislative Update

Federal.

Budget: Last week, DoD released its 2018 budget proposal. According to MOAA, the document included large increases in TRICARE fees across the board. The proposed fee increases will be directed towards Retirees under the age of 65 and their family's active duty family members who choose not to enroll in TRICARE Prime. MOAA believes these fee increases are disproportional as DoD's healthcare costs continue to decrease and do not reflect the service and sacrifice of the beneficiaries who have earned the health care benefit. - See more at: <u>http://</u> www.moaa.org/

VA: The White House unveiled its Veterans Complaint Line, to give veterans direct access to the Trump administration. Veterans can voice their concerns or individual complaints by calling (855) 948-2311. The call center will be fully operational in August. Then, veterans can expect 24-hour continuous coverage. The complaint line is a vehicle for the VA to start collecting, processing, tracking, and responding to complaints in a more responsive way. The VA will use the data to improve the delivery of high quality health care and benefits to veterans and their families in a measurable way.

State.

Tennessee's budget for the coming year is just above \$37 billion, an increase over previous years. Monday, Governor Haslam held ceremonies in three different areas of the state to sign the <u>IMPROVE Act</u>. This legislation also restores the property tax exemption to \$175k for 100% permanently and totally service disabled veterans was a success. In addition to the IM-PROVE Act, lawmakers this session approved the Governor's plan to offer tuition-free community college to eligible members of the Tennessee National Guard.

-State Sen. and MOAA member Mark Green says he will not resume his bid for Tennessee governor. Green said he will remain in the state Senate, but focusing his future towards DC where he feels there is opportunity to make significant improvements.
