Matt Dunn Retired, Supervisory Special Agent FBI

Mr. Matt Dunn has been an Associate Managing Director of Cyber Security and Investigations Practice at Kroll Inc. since February 6, 2018. Mr. Dunn joins Kroll after a distinguished 20-year career with the Federal Bureau of Investigation, where he most recently served as the Supervisory Special Agent overseeing the FBI Cyber Crimes/Counterintelligence Squad in Nashville.

Mr. Dunn has an exceptional combination of professional experiences garnered in federal law enforcement as well as in the practice of law handling litigation matters in both federal agency and private practice contexts. He oversaw national security and criminal computer intrusion investigations, particularly those impacting victims in the Middle District of Tennessee. Concurrently, he also served as the Supervisory Special Agent for the FBI Memphis Division SWAT Team, to which he was appointed in 2011.

Prior to this assignment, from 2010-2014, he served as the supervisory Special Agent for the FBI Nashville Violent Crime Gang Task Force. He began his career with the FBI as a Special Agent in the Philadelphia Field Office in 1997, where he was assigned to the Latin American/Caribbean Drug Squad. He subsequently was promoted in 2002 to a Supervisory Special Agent in the FBI's Terrorist Financing Operations Section in the Counterterrorism Division at FBI Headquarters in Washington, D.C. From 2005-2010, he served as an Assistant Legal Attaché and opened the Toronto Sub-Office of the FBI's Ottawa Legal Attaché. From 1992-1997, he served as an attorney in the Litigation Division of the Federal Deposit Insurance Corporation.

He earned his Juris Doctor at the University of Bridgeport School of Law and a Bachelor of Science degree at the University of Massachusetts.

We continue with the annual chapter dues rate of \$20.00 per officer and \$5.00 for surviving spouses. The VA Mission act of 2018 directed the department to provide access to walk-in care for veterans who are eligible for VA health care. The VA is calling it "urgent care" which is a well-known industry standard instead of "walk-in care". When implemented, care will be for medical conditions that usually don't require any follow-up procedures such as flu, bad cold, sprained ankle etc. The VA published a notice in the Federal Register on January 31, 2019 and will be accepting comments for 30 days. Once the comments are reviewed the VA will implement the final regulations later this year.

We have a very interesting program scheduled for this month's meeting. We will welcome Matt Dunn, retired FBI agent who will be talking about working with the military in Iraq and trends in Cyber-crime. Mark your calendar for the 26th. Look forward to seeing everyone.

MOAA Legislative Update

- A House-Senate conference committee tasked with ironing out differences in separate versions of the defense authorization bill has rejected Senate-passed provisions that would have sharply increased TRICARE fees, deductibles and co-pays for a million retirees under age 65.
- Congressional lawmakers who in recent weeks shaped a final \$716 billion John S. McCain National Defense Authorization Act for Fiscal Year 2019 (HR 5515) also voted to allow disabled veterans, Purple Heart recipients and caregivers of veterans severely injured in war to shop on military bases, paying slightly more at checkout than current patrons. They also will be able use base recreational facilities.
- The National Commission on Military, National, and Public Service issued an interim report last week hinting that major changes could be coming to the Selective Service System, such as requiring women to register or, conversely, abandoning the registration system altogether. The panel is still gathering information, with a final report due in 2020.
- Acting Defense Secretary Patrick Shanahan has set up a
 "coordination cell" within the Pentagon to finalize the Defense
 Department's Space Force proposal. "We are preparing for the
 rollout of the proposal, finalizing our messaging and coordinating actions," Lt. Col. Joseph Buccino says.
- The VA can't deny disability benefits to so-called "blue water"
 Navy veterans who say they were exposed to toxic chemicals
 while patrolling the coastline during the Vietnam War, according
 to a ruling by the US Court of Appeals for the Federal Circuit. The
 VA has 90 days to decide if it wants to take its appeal to the Supreme Court.
- The number of military members diagnosed with nonalcoholic fatty liver disease increased sharply from 2000 to 2017, according to the Medical Surveillance Monthly Report from the Defense Health Agency. The Air Force had the highest rate, and more men than women were diagnosed with the disease.
- Veterans who were notified last year that they may qualify for federal tax refunds related to disability severance pay must file an amended return by July to get the funds, says Lt. Col. David Dulaney of the Armed Forces Tax Council. Veterans who had taxes withheld from disability severance pay as far back as January 1991 have a year from when they received the notice to amend their returns.
