Art enlisted in the Army out of high school at age 17 in 1964. He was initially assigned to Field Artillery and spent a year in Korea on the DMZ on a Forward Observer Team. He was promoted to Sergeant E-5 after only 20 months service, and was subsequently accepted to Flight School, where he graduated as a Warrant Officer in October 1967. After attending the Air Rescue School, he was sent to Vietnam as a Medevac pilot in the 15th Medical Bn, 1st Air Cavalry Division. He flew rescue missions during the Tet Offensive, where he was wounded on 7 April. He was promoted to Aircraft Commander after only three months, then promoted to Chief Warrant Officer, and wounded again on 24 July. He received a battlefield promotion to First Lieutenant at end of his tour.

Art and his Medevac crew members are recipients of the DUSTOFF CREWS OF THE VIETNAM WAR CONGRESSIONAL GOLD MEDAL ACT award, approved on September 26, 2024.

The following is an excerpt from the documentation supporting the award of the Gold Medal:
On 24 July 1968, Warrant Officer Jacobs,, while attempting to rescue 11 wounded soldiers and retrieve 5 KIA's from Bravo Company, 2/8th Cavalry Regiment, 1st Air Cavalry Division, had three aircraft shot out from underneath him over a four-hour period in the mountains on the Vietnam border with Laos. After two emergency landings, on his third flight, his engine failed due to damage caused by the intense enemy automatic weapons fire from less than 50 meters away. Warrant Officer Jacobs managed to crash land his aircraft, but he and the crew found themselves immediately surrounded. Deploying his men into a defensive position and successfully fighting off the attack, Warrant Officer Jacobs, despite two bullet wounds, led his crew under fire through the jungle to a small jungle clearing where they were eventually rescued.

Legislative Update

MOAA Leaders go to Washington this month as a group to ask our representatives and senators to support legislation of interest to our community at the national level. There are a LOT of issues going on all the time, but MOAA identifies a few for special attention. I wrote about the chosen four bills last month; now comes my asking for you to visit the Advocacy-in-Action section of the MOAA.org website and send them some mail. To support our visits, mail in quantity makes significant impact.

Last month I wrote about the contents, and this article is about sponsorship and co-sponsorship.

Shutdown Fairness Act (S.3168) is sponsored by Sen. Ron Johnson of Wisconsin with 7 cosponsoring senators (none from Tennessee) and matches H.R.5801 sponsored by Rep. Dusty Johnson with 17 cosponsors (none from Tennessee). When you write, please do request for Cosponsorship.

Military Care Act (HR.6796) is sponsored by Rep. Stephen Hersford of Nevada and has 9 cosponsors but none from Tennessee. There is no matching bill in the Senate.

Governing Unaccredited Representatives Defrauding VA Benefits Act, acronym is **GUARD, (HR.1732)** is sponsored by Rep. Chris Pappas of New Hampshire and lacks a matching bill in the Senate. Of 121 cosponsors, 3 come from Tennessee but none from Middle Tennessee.

Major Richard Star Act (S.1032 & HR.2102) has been around for years and never quite gets across the finish line. It is sponsored by Sen. Richard Blumenthal of Connecticut with 78 cosponsors including our Sen. Blackburn but not Sen. Hagerty and by Rep. Gus Bilitakis of Florida with 319 cosponsors with 4 from Tennessee but not including ours from Middle Tennessee.

You can always track legislation using the congress.gov website – very handy!

When you visit the Advocacy section of the MOAA.org website, please make special visits to the Advocacy section of the website this month to help make greater impact. When you write, do mention the bill numbers that are shown, because legislators and staffers understand that you have done your homework when they see that you know the bill numbers. I will report back on our visits in the May column.
